The limited warranties described herein are warranted to the original purchaser and are SUBJECT TO THE PROCEDURES, LIMITATIONS, DISCLAIMERS, EXCLUSIONS, AND PROVISIONS SET FORTH HEREIN. These limited warranties cover only approved applications at the disclosure of Teem Wholesale Inc. Installer should review with the end consumer all warranty and adjustment capabilities of the product.*

#### **25 Year Limited Warranty**

Liberty Doors are warranted by Teem Wholesale Inc. to be free from manufacturing defects in milling, dimensions, and grade that would render those doors unserviceable or unfit for the ordinary purposes for which doors of that kind are recommended. All interior doors manufactured by Teem Wholesale Inc. ("Teem") on or after January 1, 2013 are warranted by Teem to the original Consumer, as defined below, for a period of 25 years from the date of shipment. The "original Consumer" is defined as the first consumer purchaser (disregarding purposes of resale) of any Liberty Product whether from Teem Wholesale Inc. or a commercial supplier, typically being used for personal or residential purposes. The warranty cannot be assigned or transferred to another individual regardless of the remaining warranty balance of the original product. The warranties set forth by Teem Wholesale Inc. cannot be altered or changed under any circumstances. Here it states that no distributor, salesperson, dealer, retailer, or other representative has the authority to make any alterations to a warranty either verbal or written.

Each Liberty Door should be inspected when initially received by the Consumer. If at that time a defect is determined, the Consumer shall file a claim with a Teem Wholesale Inc. representative. At that time Teem will investigate the defect and take appropriate action within 30 days of your original claim. Claims involving warp of a door slab are subject to be deferred for a period of twelve (12) months from the date of the preliminary claim. It is not uncommon for a hardwood door to warp as it adjusts to the local temperature conditions and humidity. This deferral will not count against the warranty period of a Liberty Door.

Should the delivered product be determined to contain defects in the material or workmanship, Teem will at its discretion, either repair the product or ship a replacement door of the same specifications of the original order, to the distributor or person making the warranty claim. UNDER NO CIRCUMSTANCE SHALL TEEM PAY FOR LABOR, INSTALLATION OR FINISHING ASSOCIATED WITH AN ORIGINAL OR REPLACEMENT DOOR. - Any exterior door where an un-vented glass storm door is being employed causing excessive temperature build-up.

### Handling and Finishing

#### Storage and Handling

- \* When doors are received they must be inspected immediately for quality, including correct size, machining, species of veneer and finish if factory finished.
- \* Teem is **not** responsible for the installation or finishing of defective doors. If a door is found to be defective please inform a Teem representative as soon as possible, to address the issue and correct the problem in a timely manner.
- \* Handling damage is not considered a factory defect. To deter impairments on the products please handle with clean gloves and equipment.
- \* Avoid dragging products across one another and other surfaces and positioning them at steep angles.
- \* Sufficiently cover the products, but do allow for air circulation.
- \* Avoid sudden and significant changes in temperature, heat, humidity and dryness.

#### Preparation For Finishing

- \* It is impossible for Teem to evaluate all available finishes and application requirements from all manufactures. Consult your finish supplier for systems best suited for your region, exposure and project needs.
- \* Before any finishing process begins the doors must be allowed to acclimate to room temperature and humidity for a period of at least 24 hours.
- \* Test your finish prior to application to the product to detect any unfavorable reactions to chemicals in the wood or for foreign debris in the finish.
- \* Visually inspect door for defect and damaged, remove all handling marks, labels and effects of exposure to moisture with a thorough, final sanding over all surfaces of the door with a 150 or 180 grit sandpaper.  
Remove sanding dust and other foreign debris before continuing the finishing process.
- \* Doors must be properly finished before put into prolonged storage.
- \* Keep all doors elevated so that water does not pool or stand around the doors before, during and after the installation process.
- \* Wood panels and mutin bars "float" and may be knocked into alignment with a wood block and mallet. Use caution not to damage the door.
- \* Machine doors before beginning the finishing process.
- \* Apply sealer, primer, or first coat of required finish immediately after fitting, machining for hardware, etc. and before the installation of all hardware.
- \* It is the finisher's responsibility to protect glass prior to and during finishing. Caution must be used when cleaning glass as not to scratch the glass.

#### Finishing

- \* Follow finish providers instructions carefully to ensure you are using a product they authorize as suitable for the desired application.

### Finishing and Installation

#### Finishing - Cont.

- \* If any issues arise during the staining or finishing process **immediately** stop and consult the stain provider, in addition to Teem Wholesale, Inc. Do **not** complete the finishing process.
- \* When staining or painting, avoid the use of dark colors, especially in cases where the end use will be in areas of heightened exposure to sunlight.
- \* A wood conditioner or stain controller may be applied prior to staining to promote a uniform appearance. Soft woods may not accept stain evenly; the use of a sanding sealer prior to staining or finishing may produce a more even look. Note: as the sealer allows for more even stain application, it may also reduce grain contrast and the depth of stain penetration.
- \* Make sure products are dry before the finishing process begins. Avoid finishing them shortly after rain, damp weather or during periods of higher than average humidity.
- \* Once you begin the finishing process, avoid starting and stopping for extended periods of time.
- \* All surfaces of the door must be properly finished. The edges (top, bottom and sides) should be coated with each and every coat of finish that is applied to each face of the door.
- \* Finish the product with quality solvent-borne or waterborne polyurethane.
- \* If you paint the product, be sure to seal it with a quality primer and top with two coats of paint.
- \* At least 3 coats of an exterior grade top coat with a UV inhibitor **MUST** be applied to any doors with continuous or potential exterior exposure. Marine grade finish is recommended to ensure the best overall protection of your door.
- \* Ensure that all exterior glass has a cap bead of clear silicone applied around the perimeter of the glass on the exterior side. If applied mouldings are being used for an exterior function both edges of the moulding should also be sealed in a like manner.
- \* In specific cases where your exterior doors have been manufactured from "rustic" or "knotty" variations of a species, all open voids must be properly finished. Ask your finishing manufacturer for the most receptive product to compliment your finish application and seal and/or fill each void to ensure quality protection from the elements.
- \* Annual inspection of the door is necessary and is recommended at least once per calendar year. If an exterior product is facing the west or south more frequent inspections will be required due to higher exposure to the elements.

#### Installation

- \* Inspect all wood doors prior to installation on the job site. Field repair and final finishing involves filling nail or screw holes, refinishing of raw surfaces resulting from job fitting, repair of job-inflicted scratches and marks, and final cleaning surfaces. Field repairs are the responsibility of the installing contractor.
- \* The structural strength of the doors must not be impaired in the fitting the opening, in applying hardware, in preparing for lites and/or louvers or any other detailing.
- \* Use a minimum of 3 hinges per door for hanging doors 84" and under. Doors over 84" should have at least 4 hinges per door.

### Installation

#### Installation - Cont.

- \* When hanging a door, allow adequate clearance for swelling of door or frame in extremely damp weather.
- \* Exterior doors should be installed under a sufficient overhang. We recommend a typical overhang to extend 1/2 the overhang height from the exterior of the home and for severe exposure (S, SW, W) the overhang should extend a minimum of the entire overhang height.
- \* In climates experiencing significant rainfall and or sun exposure, a larger overhang is required to protect the door from excessive abuse from the elements.
- \* If a door has been installed with a closer, the use of doorstops or wedges with the purpose of holding the door open are not recommended. Exaggerated warping may occur from such products due to uneven pressure on the door.
